One-Time Initiation Fee - (Check One)

- Full - \$750 at time of sign-up
- Associate - \$87.50/year for 10 years; total of \$875 or \$175/year for 5 years; total of \$875
- Junior, 28 and younger
Anyone single or married, who is 28 years of age or under at time of joining, pays \$40 per year. Upon reaching the age of 29, the member then pays \$87.50 or \$175 per year as an Associate Member until a total of \$875 is paid. (Age is determined as of Jan. 1 of the year joining or renewing.)

 - Any single person 23 years of age or younger on January 1 is entitled to full membership under his/her parents' membership, regardless of residence. On the date of marriage, he/she MUST have his/her own membership.
